**ORDINANCE NO. 3395**

**AN ORDINANCE TO AMEND AN ORDINANCE CODIFIED IN THE CODE OF THE TOWNSHIP OF NUTLEY, CHAPTER 228, ENTITLED VEHICLES AND TRAFFIC, PARTICULARLY ARTICLE IX (ANGLE AND PERMIT PARKING), SECTION 32 ENTITLED “PERMIT PARKING”**

**BE IT ORDAINED** by the Board of Commissioners of the Township of Nutley that pursuant to the authority granted to this municipality by N.J.S.A. 39:4-197(1)f, Section 32 of Chapter 228 of the Code of the Township of Nutley, entitled “Permit Parking”, is hereby amended to ADD the following;

**Chapter 228 – Section 32. Permit Parking.**

**Add**

**B. Resident Permit Parking** - The Nutley Police Department may issue resident parking permits/stickers to residents who reside on the streets listed below. These permits will be issued on a trial basis and the program will be re-evaluated after 6 months by the Director of Public Safety to ensure that it addresses the needs and concerns of the community. Residents’ vehicles that have obtained and display a resident parking permit/sticker shall be exempt from the two-hour time limit parking from 8:00 a.m. to 10:00 am. only on such street where the vehicle is registered and after complying with the following provisions:

1. The resident must complete an application and provide proof of residency, vehicle registration and a valid insurance card. Proof of residency may be established by displaying a driver’s license and/or utility bill with current address. In addition,
  - a. Leased Vehicles – either the insurance card or lease documents must reflect an address in the Township of Nutley
  - b. Company Owned Vehicles – proof of residency, written authorization of the entity owning the vehicle confirming the employee’s right to use the vehicle
2. The vehicle must be principally garaged in the Township of Nutley.
3. Resident parking permits/stickers shall be valid for a period of one year provided the resident maintains residency at the permitted location during the year period. Permits/stickers are non-transferrable. Permit/stickers will be issued by the Nutley Police Department who will maintain a record of all valid permits.
4. Resident Parking Permits/stickers shall be placed in the driver’s side rear window. Owners shall be responsible for ensuring that permits/stickers are visible and not covered by snow or other obstructions. Vehicles with permits/stickers that are not visible shall be considered in violation.
5. Vehicles are not permitted to park in any area specifically prohibited by any section in this code, or in any areas where parking is not permitted by state law.
6. Parking in accordance with this exception may be suspended by the Township in

the case of an emergency or weather related event.

**FEES:** There will be a \$5.00 administrative fee for the resident for the six (6) month period and a \$5.00 replacement fee for renewals and lost/stolen permits/stickers.

**Penalty.** There shall be a penalty of (\$24.00) dollars for violation of this section.

**Enforcement.** The Nutley Police Department has full authorization to enforce any violations of this ordinance.

**Maintenance.** The Nutley Department of Public Works will erect and maintain signs so stating ‘Permit Parking Only 8:00a.m. to 10:00a.m. except Saturdays, Sundays & Holidays’ as per MUTCD standards.

**BE IT FURTHER ENACTED** that all other terms and conditions and locations in Section 32 and Chapter 228 shall remain as heretofore set forth in the Code of the Township of Nutley, except where such a reading would not give meaning to and further the application of this amendment. In such case and in such event, the terms and conditions shall have a meaning consistent with the intent of this amendment; and

**BE IT FURTHER ENACTED** that the within ordinance shall become effective after passage and publication, pursuant to law.
